

RIGHTS AND OBLIGATIONS OF THE KRANJSKA GORA BIKE PARK USERS

Operating Hours

Bike Park Kranjska Gora (hereinafter BP Kr. Gora) operates according to the schedule, published on the official website (<https://www.ski-kranjska-gora.com/sl/summer>) and/or at the park location. Operations are subject to weather and technical conditions.

Use of Chairlifts and Lifts

Chairlifts and lifts are intended for transporting cyclists and bicycles to the top of the trails. Usage is permitted only with a valid ticket or season pass. Cyclists must follow the instructions of the staff, check the rules for safe boarding/exiting, and secure their bicycle properly. It is strictly forbidden to transport persons under the influence of alcohol, drugs, or other psychoactive substances.

Trails

The trails are suitable for cyclists of various skill levels and are regularly maintained; however, natural factors (rain, erosion) may affect their daily condition.

- The trail is not suitable for complete beginners.
- Your first ride should be dedicated to getting to know the trail and the obstacles on it.
- Adjust your speed to the characteristics and conditions of the trail, especially in case of bad weather.
- Do not endanger others, especially less experienced cyclists.
- Do not leave the marked trails and ride only on the designated route.
- Do not stop on blind sections of the trail or jumps.

Use of the Trails

- The trails are intended exclusively for cycling in the marked direction.
- Walking, running, or other activities on the trails are forbidden, except for maintenance or rescue operations.
- Use of the trails outside of operating hours or without a valid ticket is not permitted.
- Climbing the trail, whether on foot or by bike, is strictly forbidden.

TERMS OF USE

By purchasing a ticket, using the slopes, or purchasing a season pass, you agree to the following terms and conditions:

- Riding on the trails is at your own risk.. The trail operators, RTC Žičnice, Kranjska Gora d.o.o. and MTB Republic, Rok Dokl, s.p. are not liable for bodily injury, damage to bicycles or cycling equipment, or theft of bicycles or cycling equipment that may occur while using the bike park.
- Prohibition on use under the influence: Use of the trails, chairlifts, and ski lifts is strictly forbidden for persons under the influence of alcohol, drugs, or other psychoactive substances. Staff reserve the right to confiscate tickets, deny access to the trails, or revoke season passes.
- Age restrictions: Persons under the age of 18 may use the course only with a signed consent form or parental permission. Persons under the age of 15 must be accompanied by a parent, guardian, or adult. (Parents are responsible for the safety of minors.)

- Prohibition of unauthorized modifications to the trails: Modifying the trails, adding obstacles, or constructing your own elements is prohibited. Staff reserve the right to revoke tickets, trail access, or season passes.
- Follow staff instructions: Cyclists must follow the instructions of BP Kr. Gora staff, including warnings regarding trail closures due to maintenance, bad weather, or other reasons.
- Mandatory equipment: Use of a safety helmet. The use of protective gear is recommended.
- Prohibition on the use of unsuitable bicycles: Use only bicycles suitable for the trails.
- Prohibition on entry by unauthorized persons: Entry to the trails without a valid ticket or outside of operating hours is prohibited.
- Consideration of weather conditions: The operator reserves the right to close the bike park for safety and technical reasons (fire, storm, lightning, severe weather, poor weather forecast...) and other extraordinary events. If a user voluntarily leaves the bike park before the ticket expires although Bike Park is still open, no refund will be issued.
- Users transport bicycles on the chairlift at their own risk. Regardless of whether users load their bicycles themselves or are assisted by an employee of Žičnice Kranjska Gora d.o.o. We are not liable for any damage to the bicycle.
- Obligation to report accidents: If you are involved in or witness an accident or injury, immediately notify the responsible staff at Žičnice Kranjska Gora d.o.o. or call 112.

Motor vehicles: Driving motor vehicles on the BP Kr. Gora trails is strictly forbidden.

- Animals: Dogs and other pets are not allowed on the trail.
- Chairlift tickets are non-transferable.
- Failure to comply with the rules will result in immediate confiscation of the ticket.
- Photography and Videography

*Personal Use - Photography or videography for personal purposes is permitted, provided it does not obstruct other cyclists or staff.

*Marketing purposes (By entering BP Kr. Gora), visitors agree that they may be photographed or filmed by park staff or authorized photographers. These photographs or videos may be used for marketing purposes, including publication on websites, social media, or other promotional materials of BP Kranjska Gora. If a visitor does not wish to be photographed, they must explicitly inform staff when purchasing a ticket.

*Commercial use (Permission from the operator is required for photography or filming for commercial purposes).

By making this purchase, I confirm that I have read the terms and conditions carefully and am familiar with the rights and obligations of bike park users. I agree to ride at my own risk and that, in the event of injury, I will not hold the bike park operator liable.
